

Exclusive Label Distribution Agreement

Exclusive Label Distribution Agreement dated _______, 2023 by and between Music For World Peace Records (Label) and **ArtistName** (Artist), **SongwriterName** (Songwriters) and **GraphicArtist** (Graphic Artist). All parties hereby agree to enter into an exclusive agreement with Label, for release of a song titled "**SongName**" subject to the following provisions:

Term:

3 years from the date herein.

Ownership of Master:

MasterOwner is exclusive owner of the master recording of "**SongName**". During the term of this agreement, any net profits from the use or licensing of this master, whether received by label or by master owner(s), will be divided as described in the paragraph below titled "Revenue Shares". Upon termination of this agreement, **MasterOwner** will retain ownership and full licensing rights of master recording. If no contract supersedes this one, the same split rates will apply in perpetuity.

Performing rights organizations:

Performing rights organizations will make payments directly to registered artists, writers and publishers. Label shall not receive any share of income received by such organizations.

Advertising/Promotion:

It is understood that Label's marketing resources are limited. Not withstanding, all parties to this contract agree to use their best efforts with all free resources currently available and any acquired during the term of this agreement. The success of each project depends on each individual's marketing efforts.

All promotional out-of-pocket costs will be at the sole discretion of the individual who chooses to do so. It is understood that doing so will not change the shares as described in this agreement unless agreed upon by all parties prior to making that purchase.

Label obligations:

Facebook ads

At the request of any party to this contract, label will provide available resources and guidance to anyone wishing to prepare a Facebook ad campaign at their own expense. Using label's Meta Business Suite, label will coordinate all campaigns related to the promotion of "SongName".

Additionally, all parties to this agreement reserve the right to run their own ad campaigns from their own Meta Business Suite or other sources without permission from other parties to this contract.

Release on label's website

Within 3 days after the final signature appears on this agreement, or the date of this agreement, whichever is later, assuming all prior release obligations have been met, label will add "**SongName**" to Label's website and offer donation-optional downloads.

It is understood that there is a 3-day wait period between label releases and other promotional announcements. If this results in a delay, the aforementioned obligation will be met on the next available date.

Worldwide distribution

Within 7 days of release on label's website, label shall upload "**SongName**" to CD Baby to make the recording available on all digital platforms serviced by CD Baby. Label will notify all parties to the actual release date when the upload has been completed and will inform all parties of any changes prior to approval by CD Baby.

Other obligations:

Prior to finalization of this agreement, lyric writer(s) will provide label with typed lyrics in a format that can be copied and pasted without any editing. Preferred documents are MS Word, Open Office Text or .pdf format.

Prior to finalization of this agreement, lyric writers will send a story of how and why the song was written. This and lyric sheets may be sent to Taylor Sappe either by Facebook PM or email at admin@MusicForWorldPeaceRecords.com.

During the term of this agreement all parties agree to

- · Maintain an active Facebook account.
- Remain a member of the Music For World Peace private Facebook group.
- Maintain a PayPal account for receiving payments.
- · Notify label of any changes in email address connected to their PayPal Account.

Accounting:

Label shall account to all parties to this agreement no later than 30 days following the end of the quarter in which net profits were received for disbursement in an amount of \$50 or more.

If no funds are available for payment at the end of any given quarter, label will provide a quarterly sales report to any party to this agreement who requests it. Such sales reports may be screenshots or live video feeds of the sales shown in all receipts. Due to the amount of data that needs to be collected, label will have up to 30 days from the date requested to provide this report.

Payment:

All payments will be made via PayPal. If recipient cannot get a PayPal account, arrangements must be made by recipient to have someone with a PayPal account collect funds on their behalf.

It is understood that this is the only method of payment made by label and any unclaimed funds after 14 days will be refunded to label and placed back into the pool, as though it were a donation for "**SongName**". Returned funds will be placed on split sheet calculator as donations and will be divided as such when the next payment threshold has been reached.

Revenue Shares:

The split sheet shown below indicates the division of net profits. A dummy amount of \$100 has been entered into the split sheet to show percentages, with \$1 equal to 1% to \$100 being equal to 100%. When real funds are received a real dollar amount will replace the dummy amount and the split sheet will automatically calculate each person's share.

Net profit is defined as revenue actually received by label after all fees by providers and payment aggregators have been taken out.

Publisher:

Captain Blue Music, will receive publishers' share only from revenue received from donations, sales and licensing during the term of this agreement. Captain Blue Music shall not receive any back end royalties from any performance rights organizations.

Upon termination of this agreement, Captain Blue Music will receive publisher's revenue earned, as described in the split sheet, only up to the date of the termination.

Pub2 may list himself as owning 100% of the publishing when registering **SongName** with his own PRO.

Artwork:

GraphicArtist guarantees that the artwork provided to label is original artwork and free from copyright infringement and accepts full responsibility for any attorney's fees and infringement payments in the event of any claim against label by another party.

Song:

SongwriterName guarantees that the song provided to label is an original song and

they are the sole owner of the song and it is free from copyright infringement and accepts full responsibility for any attorney's fees and infringement payments in the event of any claim against label by another party.

Expiration:

Upon expiration of this agreement, label will settle any unpaid funds received by label up to the expiration date of this agreement, regardless of amount. Settlement will be made within 30 days following the expiration of this agreement. If this agreement is not renewed by one or more party all payment obligations under this agreement between the non-renewing parties and label shall be terminated after final payment is made.

Disputes: In the event of disputes to this contract or litigation of any kind, all laws of the Commonwealth of Pennsylvania, USA will apply. If any other law should conflict with Pennsylvania law, Pennsylvania law will prevail.

Any portion of this contract that does not comply with Pennsylvania law shall not be enforceable.

Cancellation: This agreement may be canceled with a 30 day or longer notice if any of the following statements become true prior to expiration:

- All parties are in agreement that the contract should be canceled.
- Any label executive agrees that any party signed to this agreement has caused damage of any kind to Label.
- Any of the parties are proven to be in breach of this agreement.

Upon termination of this agreement label will have 30 days to settle all payments to canceled parties. If any party to this agreement is unable to receive payment via PayPal, recipient must provide a mailing address within 30 days of termination to receive a check. Failure to do so will result in forfeiture of any funds due.

Upon settlement, no remaining parties to this agreement shall have any further obligation to terminated parties.
